Margaret S. Boone (Ph.D., Ohio State University) is a Health Science Specialist with the Health Services Research and Development Service of the Veterans Administration. She is also Chair of the Committee on Ethics of the American Anthropological Association, 1984–86. Her research interests have focused on health policy issues related to black maternal and child health within the American health-care system.
